3. Bids/quotations may be submitted thru fax, email or directly to the BAC Secretariat Office **on or before** the deadline of submission of bids.
4. **Suppliers are required to submit the following prior to the notification by the BAC of the award:** a) Valid and Current Mayor's/Business Permit 2017; b) Valid and Current PhilGEPS Registration Certificate/Number; c) Income/Business Tax Return; and d) Omnibus Sworn Statement.
5. Bids should be valid for 60 days counted from the deadline of submission.
6. **Delivery Period: 30 Calendar days upon receipt of Purchase Order**
7. **Retention:** The obligation for the warranty shall be covered by either retention money in an amount equivalent to at least one percent (1%) of every progress payment, or a special bank guarantee equivalent to at least one percent (1%) of the contract price.
